Minutes of the 38th Annual General Meeting of Sri Lanka Administrative Service Association

38th Annual General Meeting of Sri Lanka Administrative Service Association was held on 26th October 2021 from 10.00 a.m. to 12.30 p.m. at Nila Medura Auditorium, Colombo 05. Hundred and ten participants physically joined this meeting along with the online participants.

Hon. President of the Association Mr. Pradeep Rathnayaka announced that the meeting commenced and all the members stood up and sung the theme song of SASA. Afterwards Hon. President explained the purpose of the meeting.

According to the agenda Hon. Secretary Mr. Aruna Devendra tabled the 37th AGM Minutes and annual report for the period from 28.03.2019 to 20.05.2020. Mr. K.P.G Sumith Shantha and Mr. Janaka Premarathne proposed and approved that the minutes and the report were in order subjected to no amendments.

Hon. Treasurer Mr. Pradeep Lakshantha submitted the audited accounts for the period from 01.01.2019 to 31.12.2019. Mr. Dammika Muthugala and Mr. K.P.G Sumith Shantha proposed and approved that the audited accounts were in order.

Later on, the President thanked the membership for all the support given for the activities during the tenure of 37th Executive Committee and stated that all the Exco members are resigning from their posts. Also Mr. Padula Sri Rohana De Silva, uncontested, elected President for 38th Executive Committee, was invited to accept the Chair.

Then the relevant proposals for the constitutional amendments of SASA constitution were discussed elaboratively. Mr. Ranjith Ariyaratne proposed that due to the prevailing pandemic situation the elected SASA executive Committee should hold office until the year of 2023 and it was unanimously agreed. Furthermore, it was unanimously agreed to incorporate the following constitutional amendments.

01. Financial year of Sri Lanka Administrative Service Association should be from 01st of April to 31st March of the subsequent year.
02. To ensure the representation of Sri Lanka Divisional Secretaries' and Assistant Divisional Secretaries' Association, two new Deputy President posts (02) are established and the nominations are summoned for the afore mention posts from Sri Lanka Divisional Secretaries' and Assistant Divisional Secretaries Association.
03. Reducing the Number of Exco Committee members from 15 up to 09 from up-coming Exco Committee to be elected at an Annual General Meeting.
04. Utilizing SASA official website and email for communication of all the messages and announcements to the membership. Summoning Notice of the AGM and Calling of Nominations and all the relevant affairs should be done using the electronic method and by using the website.
05. It is suitable to use an online system when holding all the meetings of the Association including the Annual General Meeting.

There was a detailed discussion regarding the other proposals submitted and it was decided to act as follows,

01. Proposal regarding the transfer procedure of the officers of Sri Lanka Administrative Service should be discussed further and future actions should be taken.
02. It should be further discussed and decided to grant the membership for 2019 (Limited) SLAS batch should be done without causing a detriment to the judicial action.

After the session for discussion the new President addressed the gathering. Since the upcoming period is highly challenging it was emphasized that all should act together in dedication for the future betterment of the Association as well as Sri Lanka Administrative Service. Hence it was stated that the support of all the members is required in this regard.

Subsequently the new Secretary Mr. Pradeep Lakshantha delivered the vote of thanks and the affairs of the meeting were concluded.
